It is estimated by the Centre for Mental Health that 1.5 million under-18s will need new or extra help with their mental health as a direct result of Covid, The record 420,314 young people being treated every month by NHS services are likely to be part of the total, but even if they all are that still leaves almost 1.1 million more yet to seek help.



#### SUPPORTING THE MENTAL HEALTH OF NEURODIVERSE CHILDREN AND YOUNG PEOPLE

Mental health problems are increasingly seen in neurodiverse young people who have more complex needs. SEN students are six times more likely to suffer with mental-health issues and all too often the support available for education settings does not consider students who are neurodiverse.

This practical masterclass has been put together to help you to understand why this group of people are more likely to suffer mental health problems and how that can manifest. You will hear about 'affective education' and how it can be used to support pupils with social and emotional skills.



#### CAMHS: IMPROVING MENTAL HEALTH SUPPORT AND ACCESS IN SCHOOLS
